1. Final Food and Beverage options must be submitted no later than 6-weeks prior to the outing. **All alcoholic beverages must be purchased from Green Pond Country Club.**
2. A preliminary count of participants is due fourteen (14) days prior to the event.
3. A final head count is due seven (7) days prior to the event. This number will be used as a guaranteed minimum for billing purposes. If your count drops the day of play, you are still responsible for the guaranteed minimum.
4. The course has the right to change the event to a modified shotgun and open the course to the public if the number of players drops below the minimum of 80 golfers required.
5. The Outing Invoice should be settled on the day of play either by personal check or credit card.
6. All outings require purchase of Food & Beverage from Green Pond Country Club.
7. Any outside vendors or sponsors offering samples/tastings of food and/or beverages must be approved by Green Pond Country Club and provide a certificate of insurance.
8. All participants are required to abide by the posted rules and regulations of Green Pond Country Club. Failure, by any participant, to abide by these rules will result in the removal of the individual(s) from the facility.
9. In case of inclement weather, where the golf course is deemed unsafe or unplayable by the golf course staff, the outing may be rescheduled, or we will work together to find the best adjustment for both your organization and your golfers.
10. **All alcohol must be purchased from Green Pond Country Club.**
